This document is applicable to all organizations, regardless of the type, size, nature or complexity of the business, whether in the public, private or voluntary sector, or a not-for-profit organization.

This Standard defines the terms and definitions used throughout human resource management Standards., e.g. "employee" and "independent contractor".

This Standard is identical with, and has been reproduced from, ISO 30414:2018, *Human resource management* — *Guidelines for internal and external human capital reporting*.

As this document has been reproduced from an International Standard, a full point substitutes for a comma when referring to a decimal marker.

Australian or Australian/New Zealand Standards that are identical adoptions of international normative references may be used interchangeably. Refer to the online catalogue for information on specific Standards.
