## **Preface**

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-031, Intruder Alarm Equipment and Installations.

The objective of this Standard is to define recommendations and requirements for representation and measuring methods of performance values to be described in materials such as instruction manuals, brochures and specifications of video surveillance camera equipment.

The first part of this Standard defines requirements for description of video surveillance camera specification items. The second part defines requirements for measurement methods of video surveillance camera specification items.

This Standard is an adoption with national modifications, and has been reproduced from, IEC 62676-5:2018, *Video surveillance systems for use in security applications — Part 5: Data specifications and image quality performance for camera devices*. The modifications are additional requirements and are set out in Appendix ZZ, which has been added at the end of the source text.

<u>Appendix ZZ</u> lists the variations to IEC 62676-5:2018 for the application of this Standard in Australia and New Zealand.
