PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee QR/2 on Quality of Service and issued as a Joint Standard.

The principal objective of this Guide is to interpret and explain the requirements of AS/NZS ISO 9001:1994, *Quality systems—Model for quality assurance in design, development, production, installation and servicing* in terms readily understood and relevant to the road freight transport industry. Within this industry, there is a broad range of organizations having varying needs. Although uniformity of interpretation and terminology falls within this objective, it will be apparent that the establishment of a quality system by an organization will be influenced by numerous factors specific to the nature of the organization. As a consequence, quality systems will vary from organization to organization even in circumstances which are comparable.

In this document, each Clause from AS/NZS ISO 9001:1994 is enclosed in a box followed by the relevant guidance. Examples given in conjunction with guidance are preceded by a box titled 'Application'.
