This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL/31 on Intruder Alarm Equipment and Installations. This Standard is a result of a consensus among representatives of the Joint Committee to produce it as an Australian Standard.

It has been prepared at the request of providers of static and mobile security services to fill a need in the industry. This Standard specifies the perceived minimum requirements which are attainable by all security companies, regardless of size, and which are necessary to provide a professional and competent service to clients. Its application is intended to raise the quality of services provided and thereby improve the public image of the industry.

Users of this Standard are advised to consider the desirability of quality assurance accreditation in accordance with the procedures contained in the AS/NZS ISO 9000 series.

In preparing this Standard, cognizance has been taken of comparable Standards in the United Kingdom.

The term 'normative' has been used in this Standard to define the application of the appendix to which it applies. A 'normative' appendix is an integral part of a Standard.
