PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee ME/1, Pressure Equipment, and supersedes AS 1271 — 1990.

This Standard forms part of the AS/NZS Pressure Equipment Standard, which is referenced as AS/NZS 1200. The Pressure Equipment Standard covers requirements for water-tube, fire-tube, shell and miscellaneous boilers, unfired pressure vessels, piping, certification of welders, and related matters. Revisions and additions approved by the Committee, have been included in this edition and the changes include editorial modifications to align with Standards Australia practice.

The Standard incorporates revisions to ISO 4126-1, *Safety valves—General requirements*, where the Committee considered these to be appropriate.

This Standard is the result of a consensus amongst representatives on the Joint Committee to produce it as an Australian Standard.

Users of this Standard are reminded that it has no legal authority in its own right but may acquire legal standing in one or more of the following circumstances:

- (a) Adoption by a government or other authority having jurisdiction.
- (b) Adoption by a purchaser as the required standard of construction when placing a contract.
- (c) Adoption where a manufacturer states that a product is in accordance with this Standard.

The terms 'normative' and 'informative' have been used in this Standard to define the application of the appendix to which they apply. A 'normative' appendix is an integral part of a Standard, whereas an 'informative' appendix is only for information and guidance.
