## PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee IT-019, Information and Documentation, Information Technology—Learning, Education, Training and Research.

A1 | Amendment No. 1 to this Standard was prepared by the Australian members of Joint Standards Australia/Standards New Zealand Committee IT-019. As a consequence of Amendment No. 1, which is published as an Australian-only amendment, the designation of this Standard has been changed from AS/NZS ISO/IEC 19788.2:2013 to AS ISO/IEC 19788.2:2013.

The objective of this Standard is to specify metadata elements and their attributes for the description of learning resources. It provides a base-level data element set for the description of learning resources, from the ISO 15836:2009 Dublin Core metadata element set, using the framework provided in AS/NZS ISO/IEC 19788.1:2013.

A1 | This Standard is identical with, and has been reproduced from ISO/IEC 19788-2:2011, *Information technology — Learning, education and training — Metadata for learning resources — Part 2: Dublin Core elements*, and its Amendment 1 (2016), *Non-literal content value data elements*, which has been added at the end of the source text.
