PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee TE-003, Electromagnetic Interference to supersede AS/NZS CISPR 16.1:2002.

This Standard is identical with, and has been reproduced from, CISPR 16-1-5:2003, *Specification for radio disturbance and immunity measuring apparatus and methods*, Part 1-5: *Radio disturbance and immunity measuring apparatus—Antenna calibration test sites for 30 MHz to 1000 MHz*.

The objective of this Standard is to specify the requirements for calibration test sites, used to perform antenna calibrations, as well as the test antenna characteristics, calibration site verification procedure and site compliance criteria.

This Standard is Part 1.5 of AS/NZS CISPR 16.1, *Specification for radio disturbance and immunity measuring apparatus and methods*, which consists of the following:

Part 1.1: Radio disturbance and immunity measuring apparatus—Measuring apparatus

Part 1.2: Radio disturbance and immunity measuring apparatus—Conducted disturbances

Part 1.3: Radio disturbance and immunity measuring apparatus—Disturbance power

Part 1.4: Radio disturbance and immunity measuring apparatus—Radiated disturbance

Part 1.5: Radio disturbance and immunity measuring apparatus—Antenna calibration test sites for 30 MHz to 1000 MHz (this standard)

The terms ‘normative’ and ‘informative’ are used to define the application of the annex to which they apply. A normative annex is an integral part of a standard, whereas an informative annex is only for information and guidance.

As this Standard is reproduced from an international standard, the following applies:
