PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee BD/23 on Structural Steel to supersede AS 3679.2—1991.

The objective of this Standard is to specify requirements for welded I sections for general structural and engineering functions. These functions include the possibility of such welded I sections being subjected to dynamic and other special loads. This Standard does not cover built-up (i.e. custom-built) welded I sections designed in accordance with AS 3990, AS 4100 or NZS 3404.

This edition incorporates the following major changes:

- (a) Deletion of weather-resistant weldable grades.
- (b) References to hot-rolled plates are now referred to AS/NZS 3678.
- (c) Geometrical properties of steel sections are deleted.
- (d) Appendix B is updated.

A statement expressed in mandatory terms in a note to a table is deemed to be a requirement of this Standard.

The terms 'normative' and 'informative' have been used in this Standard to define the application of the appendix to which they apply. A 'normative' appendix is an integral part of a Standard, whereas an 'informative' appendix is only for information and guidance.
