Also the reference to IEC 439 "etal" could be confusing as IEC 439-1973 has been superseded by IEC 439-1:1985 which is not referenced in this document.

Could you please send us written clarification on the above points.

The reference to IEC 439 et al would not be confusing to readers familiar with IEC 439 as 439-1 and 439-2 need to be read in conjunction for busways.
