PREFACE

This Standard is issued as a Joint Standard under the terms of the Active Cooperation Agreement between Standards Australia and Standards New Zealand.

This Standard was prepared by the Joint Australia/New Zealand Standards Committee EL/2 on Electrical Approvals Standards to supersede AS 3160—1989 and NZS/AS 3160:1989.

This Standard is one of a series of Approval and test specifications issued by Standards Australia and Standards New Zealand. In Australia, these Standards are to be read in conjunction with AS 3100, *Approval and test specification—General requirements for electrical equipment*. In New Zealand, they are to be read in conjunction with NZS 6200, *Specification for general requirements for electrical apparatus and material*. The purpose of these Standards is to outline the conditions which must be met to secure approval for the sale and use of electrical equipment. Only safety matters and related conditions are covered.

This Standard was revised to incorporate Amendments Nos 1, 2, 3 and 4 to AS 3160—1989 and to effect changes to Table 2 and Clause 19.5 to include abnormal operations tests.

Where there is a published Australian/New Zealand harmonized or Joint Standard referenced in this Standard, the New Zealand Standard number is given in parenthesis following the Australian Standard number.

This Standard supersedes AS 3160—1989 in Australia and NZS/AS 3160:1989 in New Zealand from date of publication with the exception of Table 2 and Clause 19.5 which come into effect 2 years from the date of publication.

This Standard does not provide all the necessary conditions for a contract.

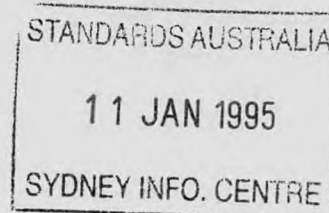
