PREFACE

This edition of this standard was prepared by the Association's Committee on Electrical Accessories to supersede AS 2053—1980.

This edition introduces a new Section 5 which specifies requirements for corrugated conduit intended for use in applications not requiring continuous flexing and having some degree of mechanical endurance, e.g. concrete pours, the following of complex profiles, or where flexibility is required. It is expected that at some later stage AS 3000 will include requirements for the installation of such conduit.

Other changes in this edition include the addition of 125 mm rigid UPVC conduit, the inclusion of minimum inside diameters of flexible conduit fittings and the updating of the flammability tests.
