PREFACE

This Standard was prepared by the Standards Australia and Standards Association of New Zealand Committees on Electromagnetic Interference. It is one of a series of Standards intended to facilitate control of electromagnetic interference and the compatibility of electrical and electronic equipment to supersede AS 1052—1988, *Electromagnetic interference—Measuring apparatus and measurement methods*. It is identical with and has been reproduced from IEC/CISPR 16:1987, *C.I.S.P.R. specification for radio interference measuring apparatus and measurement methods* prepared by CISPR Sub-Committee A. It is issued as a joint Standard under the terms of the Memorandum of Understanding between Standards Australia and the Standards Association of New Zealand with the objective of reducing technical barriers to trade between the two nations.

Under arrangements made between Standards Australia and the international Standards bodies, ISO and IEC, as well as certain other Standards organizations, users of this Australian Standard are advised of the following:

- (a) Copyright is vested in Standards Australia.
- (b) The number of this Standard is not reproduced on each page; its identity is shown only on the cover and title pages.
- (c) Where any cross-references to page numbers appear within the text, these references apply to page numbering of the International Standard at the bottom left-hand corner of each page.
