PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL/4, Electrical Accessories.

The objective of this Standard is to provide the particular requirements for twist-on connecting devices.

This Standard is technically equivalent to, and reproduced from, IEC 60998-2-4:1993, *Connecting devices for low-voltage circuits for household and similar purposes, Part 2-4: Particular requirements for twist-on connecting devices*.

This Standard (Part 2.4) is to be read in conjunction with Part 1. Where a particular clause of Part 1 is not mentioned in this Part 2.4, that clause applies as far as is reasonable. Where this Part 2.4 states 'addition', 'modification' or 'replacement', the relevant change is made to the requirements in Part 1.

A number of variations have been made in this Standard to the requirements of IEC 60998-2-4:1993. These variations, which are necessary for Australian/New Zealand requirements, are listed in Annex ZZ and are indicated in the text by a marginal bar set adjacent to the varied text.

The numbering of clauses, notes and figures closely follows those of IEC 1008-1:1990. To allow additional material to be introduced by Australia or New Zealand, the numbers 201 to 300 are used. This scheme has been introduced to reduce the likelihood of the IEC and Standards Australia or Standards New Zealand using the same numbers for different requirements.

As this Standard is reproduced from an international Standard, the following applies:

- (a) Its number does not appear on each page of text and its identity is shown only on the cover and title page.
- (b) In the source text 'this International Standard' should read 'this Australian/New Zealand Standard'.
- (c) A full point substitutes for a comma when referring to a decimal marker.
