1 Scope

This document specifies a method for the determination of pH of a solution of ammonium nitrate fertilizer of high nitrogen content.

3 Terms and definitions

For the purposes of this document, the terms and definitions given in EN 12944-1 and EN 12944-2 apply. ISO and IEC maintain terminological databases for use in standardization at the following addresses:

4 Principle

The measurement of the pH of an ammonium nitrate solution is carried out by means of a pH meter.

5 Reagents

Use only reagents of recognized analytical grade.

5.1 Distilled or demineralized water, free from carbon dioxide.

5.2 Buffer solution A, pH 6,88 at 20 °C or buffer solution B pH 4,00 at 20 °C.

For buffer solution A, dissolve $3,40 \text{ g} \pm 0,01 \text{ g}$ of potassium dihydrogen phosphate (KH_2PO_4) in approximately 400 ml of water. Then dissolve $3,55 \text{ g} \pm 0,01 \text{ g}$ of disodium hydrogen phosphate (Na_2HPO_4) in approximately 400 ml of water (5.1). Transfer the two solutions without loss into a 1 000-ml graduated flask (6.2), fill up to the mark and mix.

Keep this solution in an airtight vessel.

For buffer solution B, dissolve $10,21 \text{ g} \pm 0,01 \text{ g}$ of potassium hydrogen phthalate ($\text{KHC}_8\text{O}_4\text{H}_4$) in water (5.1), transfer without loss into a 1 000-ml graduated flask (6.2), fill up to the mark and mix.

Keep this solution in an airtight vessel.

Alternatively, commercially available pH standard solutions may be used.
