Preface

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee HE-003, Medical Electrical Equipment, to supersede AS/NZS 3200.2.35:1999, *Medical electrical equipment, Part 2.35: Particular requirements for safety—Blankets, pads and mattresses intended for heating in medical use*.

The objective of this document is to specify requirements for the basic safety and essential performance of heating devices using blankets, pads or mattresses in medical use, also referred to as ME equipment.

Requirements for heating devices intended to pre-warm a bed are also specified in this document.

This document does not apply to the following:

- (a) Heating devices intended for physiotherapy.
- (b) Infant radiant warmers (for more information, refer to IEC 60601-2-21).
- (c) Infant incubators (for more information, refer to IEC 60601-2-19).
- (d) Infant transport incubators (for more information, refer to IEC 60601-2-20).
- (e) Cooling devices.

This document is identical with, and has been reproduced from, IEC 60601-2-35:2020, *Medical electrical equipment – Part 2-35: Particular requirements for the basic safety and essential performance of heating devices using blankets, pads and mattresses and intended for heating in medical use*.

As this document has been reproduced from an International document, the following applies:

- (i) In the source text “this part of 60601 International Standard” should read “this document”.
- (ii) A full point substitutes for a comma when referring to a decimal marker.
