Foreword

The text of document 64/1404/FDIS, future edition 2 of IEC 60364-7-703, prepared by IEC TC 64, Electrical installations and protection against electric shock, was submitted to the IEC-CENELEC parallel vote and was approved by CENELEC as HD 60364-7-703 on 2005-03-01.

This European Standard supersedes HD 384.7.703 S1:1991.

The main technical changes with respect to HD 384.7.703 S1:1991 concern the updating of requirements to take into account the evolution in sauna equipment, with particular emphasis on prefabricated cabins. In addition, in response to a need from installers, there has been some elaboration on temperature repartition in saunas as well as protection against electric shock. Finally, the four zones described in the first edition have now been reduced to three zones.

The following dates were fixed:

- latest date by which the existence of the HD has to be announced at national level (doa) 2005-06-01
- latest date by which the HD has to be implemented at national level by publication of a harmonized national standard or by endorsement (dop) 2005-12-01
- latest date by which the national standards conflicting with the HD have to be withdrawn (dow) 2008-03-01
