Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Inland navigation vessels - Boarding ladders) Declaration, 1996.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Inland navigation vessels - Boarding ladders. The Schedule comprises the text of EN ISO 7371 : 1995.

(2) The said standard specification may be cited as Irish Standard/EN ISO 7371:1996 or as I.S./EN ISO 7371:1996.
