NSAI in exercise of the power conferred by section 16 (3) of the National Standards Authority of Ireland Act, 1966 (No. 28 of 1996) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Biotechnology - Guidance for quality control of diagnostic kits used in agriculture, plant and animal pest and disease control and environmental contamination) Declaration, 1998.

2. (1) The Specification set forth in the schedule to this declaration is hereby declared to be the standard specification for Biotechnology - Guidance for quality control of diagnostic kits used in agriculture, plant and animal pest and disease control and environmental contamination. The Schedule comprises the text of EN 12306:1997.

(2) The said standard specification may be cited as Irish Standard EN 12306:1998 or as I.S. EN 12306:1998.
