The Institute for Industrial Research and Standards in exercise of the power conferred by section 20 of the Industrial Research and Standards Act, 1961 (No. 20 of 1961), and with the consent of the the Minister for Industry and Commerce, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Concrete Building Blocks, Part 1, Normal Density Blocks) Declaration, 1987.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Concrete Building Blocks, Part 1, Normal Density Blocks.

(2) The said standard specification may be cited as Irish Standard 20 : Part 1 : 1987 or as I.S. 20 : Part 1 : 1987.

3. (1) The Standard Specification (Concrete Building Blocks) Declaration, 1974, is hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard 20 : 1974, thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard 20 : Part 1 : 1987.
