NSAI in exercise of the power conferred by section 16 (3) of the National Standards Authority of Ireland Act, 1996 (No. 28 of 1996) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Conical fittings with a 6% (Luer) taper for syringes, needles and certain other medical equipment - lock fittings) Declaration, 1997.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Conical fittings with a 6% (Luer) taper for syringes, needles and certain other medical equipment - lock fittings. The Schedule comprises the text of EN 1707:1996.

(2) The said standard specification may be cited as Irish Standard EN 1707:1997 or as I.S. EN 1707:1997.
