- (2) The said standard specification may be cited as Irish Standard EN ISO 9003:1994 or as I.S. EN ISO 9003:1994.
- 3. (1) The Standard Specification (Quality Systems Model for Quality Assurance in Final Inspection and Test) Declaration, 1989, is hereby revoked.
- (2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/ISO 9003/EN 29003: 1989, thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard EN ISO 9003:1994.
