- (2) The said standard specification may be cited as Irish Standard/EN 100114-1:1997 or as I.S./EN 100114-1:1997.
- 3. (1) The Standard Specifications (Rule of Procedure: Quality Assessment Procedures Part I: Approval of Manufacturers and Other Organizations) Declaration, 1994 is hereby revoked.
- (2) Reference in any other standard specification to the Instruments hereby revoked and to Irish Standard/EN 100114-1: 1994, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN 100114-1:1997.
