DECLARATION, 1988

IRISH STANDARD 419: 1988

Forfás in exercise of the power conferred by Section 20 (5) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961), and the Industrial Development Act, 1993 (No. 19 of 1993) and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

- 1. This instrument may be cited as the Standard Specification (Fire Safety Requirements for Components of Furniture) Declaration, 1988 (Amendment) No. 1: 1994.
- 2. Irish Standard 419: 1988 set out in the Schedule to the Standard Specification (Fire Safety Requirements for Components of Furniture) Declaration, 1988 is hereby amended as indicated in the Schedule hereto.

SCHEDULE

Page 13 Schedule 2 Part IV Ignitability Test for Composite Fillings of Mattresses and Bed Bases.

Clause 1 Line 1 After 'I.S. 418:1988' add 'including Amendment 1: 1994'. Clause 3 Line 1 After 'I.S. 418: 1988' add 'including Amendment 1: 1994'.

Page 14 Schedule 3 Ignition Resistance Test for Interliner.

Clause 1 to become 'An interliner which is a fabric that has been treated with a fire retardant chemical to reduce the ignitability of upholstery shall, before it is conditioned in accordance with Clause 7.1 of EN 1021 Part 2: 1993 be subjected to the Water Soak Procedure in Annex D of this Standard'.

Page 15 Schedule 4 The Cigarette Test.

This Schedule to become 'The cigarette test shall be carried out in accordance with EN 1021 Part 1: 1993'.

Page 16 Schedule 5 The Match Test Part I.

Clause 1 to become 'Any covering fabric which has been treated with a fire retardant chemical to reduce the ignitability of the upholstery shall, before it is conditioned in accordance with Clause 7.1 of EN 1021 Part 2: 1993 be subjected to the Water Soak Procedure in Annex D of this Standard'.

Clause 2 to become 'The test shall be carried out in accordance with EN 1021 Part 2: 1993. The filling material for this test shall be non fire retardant polyurethane foam of slabstock type with a density of 20-22 kg per m³ and a hardness of 120-140 Newtons.

Clause 3 to become 'The criteria for failure shall be those specified in Clause 3 of EN 1021 Part 2: 1993.

Clause 4. Omit.
