NSAI in exercise of the power conferred by section 16 (3) of the National Standards Authority of Ireland Act, 1966 (No. 28 of 1996) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Electrically propelled road vehicles - Measurement of energy performances - Part 1: Pure electric vehicles) Declaration, 1998.

2. (1) The Specification set forth in the schedule to this declaration is hereby declared to be the standard specification for Electrically propelled road vehicles - Measurement of energy performances - Part 1: Pure electric vehicles. The Schedule comprises the text of EN 1986-1:1997.

(2) The said standard specification may be cited as Irish Standard EN 1986-1:1998 or as I.S. EN 1986-1:1998.
