(1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Quality management and quality assurance standards Part 3: Guidelines for the application of ISO 9001: 1994 to the development, supply, installation and maintenance of computer software (ISO 9000-3: 1997). Schedule comprises the text of EN ISO 9000-3:1997.
- (2) The said standard specification may be cited as Irish Standard EN ISO 9000-3:1998 or as I.S. EN ISO 9000-3:1998.
- 3. (1) The Standard Specification (Quality Management and Quality Assurance Standards Part 3: Guidelines for the Application of ISO 9001 to the Development, Supply and Maintenance of Software (Identical with ISO 9000-3:1991) Declaration, 1994 is hereby revoked.
- (2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/ISO 9000-3/EN 29000-3:1994 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISO 9000-3:1998.
