EOLAS - The Irish Science and Technology Agency in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 ( No. 20 of 1961 ) and the Science and Technology Act, 1987 (No. 30 of 1987), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Optical Fibre Cables (Generic Specification)) Declaration, 1993.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Optical Fibre Cables (Generic Specification). The Schedule comprises the text of EN 187000 : 1992.

(2) The said standard specification may be cited as Irish Standard/EN 187000:1993 or as I.S./EN 187000:1993.
