NSAI in exercise of the power conferred by section 16 (5) of the National Standards Authority of Ireland Act, 1996 ( No. 28 of 1996 ) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Parallel pins with internal thread, of unhardened steel or austenitic stainless steel (ISO 8733 : 1997)) Declaration, 1998.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Parallel pins with internal thread, of unhardened steel or austenitic stainless steel (ISO 8733 : 1997). Schedule comprises the text of EN ISO 8733:1997.

(2) The said standard specification may be cited as Irish Standard EN ISO 8733 :1998 or as I.S. EN ISO 8733:1998.

3. (1) The Standard Specification (Parallel Pins with Internal Thread, Unhardened (ISO 8733:1986)) Declaration, 1993 is hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/EN 28733:1993 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISO 8733:1998.
