1. This instrument may be cited as the Standard Specification (Fixed Aluminium Electrolytic Capacitors with Non-Solid Electrolyte (Detail Specification)) Declaration, 1994.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Fixed Aluminium Electrolytic Capacitors with Non-Solid Electrolyte (Detail Specification). The Schedule comprises the text of CECC 30301-801 : 1994.

(2) The said standard specification may be cited as Irish Standard 1084:1994 (CECC 30301-801:1994) or as I.S. 1084:1994 (CECC 30301-801:1994).

3. (1) The Standard Specification (Aluminium Electrolytic Capacitors with Non-Solid Electrolyte (Detail Specification)) Declaration, 1989, is hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard 1084:1989 (CECC 30301-801:1988) thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard 1084:1994 (CECC 30301-801:1994).
