

SPECIFICATION

ENTITLED

GYPSUM PLASTERS (EXCLUDING PREMIXED LIGHTWEIGHT PLASTERS)

AS

THE IRISH STANDARD SPECIFICATION FOR

GYPSUM PLASTERS (EXCLUDING PREMIXED LIGHTWEIGHT PLASTERS)

The Institute for Industrial Research and Standards in exercise of the power conferred by section 20 of the Industrial Research and Standards Act, 1961 (No. 20 of 1961), and with the consent of the Minister for Industry and Commerce, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Gypsum Plasters (Excluding Premixed Lightweight Plasters)) Declaration, 1975.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Gypsum Plasters (Excluding Premixed Lightweight Plasters).



(2) The said standard specification may be cited as Irish Standard 27: Part 1:1975 or as I.S. 27: Part 1: 1975.

3. (1) The Standard Specification (Gypsum Plasters) Order, 1950, (S.I. No. 240 of 1950), is hereby revoked.

(2) Reference in any other standard specification to the Order hereby revoked and to Irish Standard 27: 1950, thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard 27: Part 1: 1975.
