In 1992 ISO 3995:1985 "Metallic powders - Determination of green strength by transverse rupture of rectangular compacts" was submitted to the CEN Primary Questionnaire procedure.

Following the positive result of the CEN/CS Proposal ISO 3995:1985 was submitted to the CEN Formal Vote. The result of the Formal Vote was positive.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by October 1993, and conflicting national standards shall be withdrawn at the latest by October 1993.
