- 1. This instrument may be cited as the Standard Specification (Identification Cards – Financial Transaction Cards (ISO 7813, 3rd edition, 1990)) Declaration, 1993.**
- 2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Identification Cards – Financial Transaction Cards (ISO 7813, 3rd edition, 1990). The Schedule comprises the text of EN 27813 : 1992.**
(2) The said standard specification may be cited as Irish Standard/EN 27813 : 1993 or as I.S./EN 27813: 1993.
- 3. (1) The Standard Specification (Identification Cards – Financial Transaction Cards (ISO 7813:1987)) Declaration, 1992, is hereby revoked.**
(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/EN 27813 : 1992, thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN 27813 : 1993.
