2. (1) The Specification set forth in the schedule to this declaration is hereby declared to be the standard specification for Rubber and plastics machines - Reaction moulding machines - Part 1: Safety requirements for metering and mixing units. The Schedule comprises the text of EN 1612-1:1997.
(2) The said standard specification may be cited as Irish Standard EN 1612-1:1998 or as I.S. EN 1612-1:1998.
