The text of document 85/162/FDIS, future amendment 1 to IEC 61143-1:1992, prepared by IEC TC 85, Measuring equipment for electromagnetic quantities, was submitted to the IEC-CENELEC parallel vote and was approved by CENELEC as amendment A1 to EN 61143-1:1994 on 1997-10-01.

The following dates were fixed:

- latest date by which the amendment has to be implemented
at national level by publication of an identical
national standard or by endorsement (dop) 1998-07-01
- latest date by which the national standards conflicting
with the amendment have to be withdrawn (dow) 1998-07-01

For products which have complied with EN 61143-1:1994 before 1998-07-01 as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2003-07-01.

The text of amendment 1:1997 to the International Standard IEC 61143-1:1992 was approved by CENELEC as an amendment to the European Standard without any modification.

In annex ZA of EN 61143-1:1994 the reference to IEC 60414 is to be deleted.
