- 1. This instrument may be cited as the Standard Specification (Sectional Specification: Fixed power resistors) Declaration, 1998.
- 2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Sectional Specification: Fixed power resistors. Schedule comprises the text of EN 140200:1996.
- (2) The said standard specification may be cited as Irish Standard EN 140200:1998 or as I.S. EN 140200:1998.
- 3. (1) The Standard Specification (Fixed Power Resistors (Sectional Specification)) Declaration, 1986 is hereby revoked.
- (2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard 534: 1986 (CECC 40200: 1981) thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN 140200:1998.
