Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and United-Kingdom.

Endorsement notice

The text of the International Standard ISO 3166:1993 edition 4, "Codes for the representation of names of countries", was approved by CEN as a European Standard.

The names of countries and their codes listed in EN 23166:1993 identical to ISO 3166:1993 are subject to updates.
