Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Science and Technology Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Metallic Powders – Determination of Tap Density (ISO 3953:1985)) Declaration, 1994.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Metallic Powders – Determination of Tap Density (ISO 3953:1985). The Schedule comprises the text of EN 23953 : 1993.

(2) The said standard specification may be cited as Irish Standard/EN 23953:1994 or as I.S./EN 23953:1994.

In 1992 ISO 3953:1985 "Metallic powders - Determination of tap density" was submitted to the CEN Primary Questionnaire procedure.

Following the positive result of the CEN/CS Proposal ISO 3953:1985 was submitted to the CEN Formal Vote. The result of the Formal Vote was positive.
