### Brief History

Following a proposal of the Commission of the European Communities, the Technical Board of CEN decided in 1980 to investigate the national implementation of ISO Standards in the field of "Health and safety standards for cabin installation of construction equipment".

Based on the positive result of the "Preliminary Questionnaire" procedure, the CEN Technical Board decided in March 1988 to submit the International Standard:

**ISO 5353:1978 "Earth-moving machinery and tractors and machinery for agriculture and forestry; Seat index point"**  
**with Amendment 1:1981 and Amendment 2:1984**

to the formal vote. The result of this formal vote was positive.

In accordance with the CEN/CENELEC Common Rules, the following countries are bound to implement this European Standard: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxemburg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and United Kingdom.
