## **Foreword**

The text of this Amendment EN 28662-3:1994/A2:2001 to the EN 28662-3:1994 from Technical Committee ISO/TC 118 "Compressors" of the International Organization for Standardization (ISO) has been taken over as an Amendment to the European Standard by Technical Committee CEN/TC 231 "Mechanical vibration and shock", the secretariat of which is held by DIN.

This Amendment to the European Standard EN 28662-3:1994 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by November 2001, and conflicting national standards shall be withdrawn at the latest by November 2001.
