EOLAS - The Irish Science and Technology Agency in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Science and Technology Act, 1987 (No. 30 of 1987), and with the consent of the Minister for Industry and Commerce, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Polyethylene Film Suitable for Covering Silage) Declaration, 1989.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Polyethylene Film Suitable for Covering Silage.
(2) The said standard specification may be cited as Irish Standard 246 : 1989 or as I.S. 246 : 1989.

FOREWORD

This standard which has been in use for some years as a provisional standard is now being published as a conventional standard. The technical requirements are unchanged but amendment No. 2 which superseded amendment No. 1 is incorporated in the text.

The standard covers only requirements for film to be used in covering silage. It may or may not be suitable for other uses. The standard does not deal with methods of placing the film.
