The text of document 61H/235/CDV, future amendment 1 to IEC 60335-2-71:2002, prepared by SC 61H, Safety of electrically operated farm appliances, of IEC Technical Committee 61, Safety of household and similar electrical appliances, was submitted to the IEC-CENELEC parallel unique acceptance procedure and was approved by CENELEC as amendment A1 to EN 60335-2-71:2003 on 2007-04-01.

The following dates are applicable:

- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2008-01-01
- date on which national standards conflicting with the amendment have to be withdrawn (dow) 2010-04-01

This amendment supplements or modifies the corresponding clauses of EN 60335-2-71:2003.

As a consequence of endorsing amendment 1:2007 to IEC 60335-2-71:2002, the common modification in EN 60335-2-71:2003 concerning Subclause 6.2 is covered by similar IEC text and therefore withdrawn.

There are no special national conditions causing a deviation from this amendment.
