Foreword

The text of document 86B/2267/CDV, future edition 2 of IEC 61300-2-26, prepared by SC 86B, Fibre optic interconnecting devices and passive components, of IEC TC 86, Fibre optics, was submitted to the IEC-CENELEC parallel Unique Acceptance Procedure and was approved by CENELEC as EN 61300-2-26 on 2007-05-01.

EN 61300-2-26:2007 supersedes EN 61300-2-26:1997.

Specific technical changes include the test conditions such as concentration, pH value and temperature of salt solution, relative humidity of air and regulations on final measurements.

The following dates were fixed:

- latest date by which the EN has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2008-02-01
- latest date by which the national standards conflicting with the EN have to be withdrawn (dow) 2010-05-01
