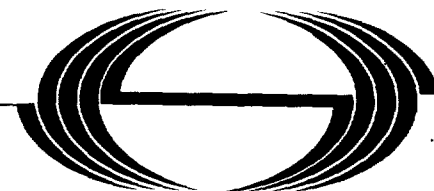
Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Signalling Protocols and Switching (SPS); Q3 Interface at the Local Exchange (LE) for Configuration Management of V5 Interfaces and Associated Customer Profiles; Part 1: Q3 Interface Specification) Declaration, 1995.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Signalling Protocols and Switching (SPS); Q3 Interface at the Local Exchange (LE) for Configuration Management of V5 Interfaces and Associated Customer Profiles; Part 1: Q3 Interface Specification. The Schedule comprises the text of ETS 300377-1 : 1994.
