NSAI in exercise of the power conferred by section 16 (3) of the National Standards Authority of Ireland Act, 1966 (No. 28 of 1996) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Agricultural and forestry machinery - Sprayers and liquid fertilizer distributors - Safety) Declaration, 1997.
2. (1) The Specification set forth in the schedule to this declaration is hereby declared to be the standard specification for Agricultural and forestry machinery - Sprayers and liquid fertilizer distributors - Safety. The Schedule comprises the text of EN 907:1997.
