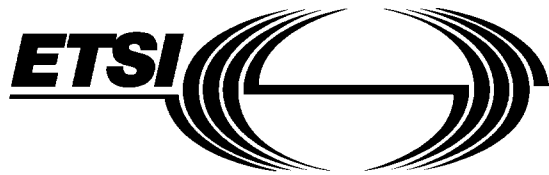

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Signalling Protocols and Switching (SPS); V Interfaces at the Digital Local Exchange (LE) V5.2 Interface for the Support of Access Network (AN) Part 1: V5.2 Interface Specification.
