1. This instrument may be cited as the Standard Specification (Information technology - International Standardized Profiles AMH1n - Message Handling Systems - Common Messaging - Part 4 : AMH12 MTS Access (P3) (ISO/IEC ISP 10611-4 : 1994)) Declaration, 1996.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Information technology - International Standardized Profiles AMH1n - Message Handling Systems - Common Messaging - Part 4 : AMH12 - MTS Access (P3) (ISO/IEC ISP 10611-4 : 1994). The Schedule comprises the text of EN ISP 10611-4: 1996.

(2) The said standard specification may be cited as Irish Standard/EN ISP 10611-4 : 1996 or as I.S./EN ISP 10611-4 : 1996.
3. (1) The Standard Specification (Information Technology – Functional Standard for Profile A/MH12 – Message Handling Systems – (1988 and later) – Common Facilities – UA to MS (P7)) Declaration, 1993 is hereby revoked.

(2) Reference in any other standard specification to the Instruments hereby revoked and to Irish Standard/ENV 41218 : 1993 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISP 10611-4:1996.
