Forfás in exercise of the power conferred by section 20 (5) of the Industrial Research and Standards Act, 1961 ( No. 20 of 1961 ) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Information technology - International Standardized Profile RA - Relaying the Connectionless-mode Network Service - Part 5 : Definition of profile RA51.51, relaying the Connectionless-mode Network Service between CSMA/CD LAN subnetworks (ISO/IEC ISP 10613-5 : 1994)) Declaration, 1996.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Information technology - International Standardized Profile RA - Relaying the Connectionless-mode Network Service - Part 5 : Definition of profile RA51.51, relaying the Connectionless-mode Network Service between CSMA/CD LAN subnetworks (ISO/IEC ISP 10613-5 : 1994). The Schedule comprises the text of EN ISP 10613-7: 1996.

(2) The said standard specification may be cited as Irish Standard/EN ISP 10613-7 : 1996 or as I.S./EN ISP 10613-7 : 1996.

3. (1) The Standard Specification (Information Systems Interconnection – Relaying the Connectionless-mode Network Service - Part 7 : PSDN Subnetwork Dependent Media Dependent Requirements for Virtual Calls Over a Permanent Access) Declaration, 1993 is hereby revoked.

(2) Reference in any other standard specification to the Instruments hereby revoked and to Irish Standard/ENV 41801-7 : 1993 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISP 10613-7:1996.
