- 2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Information technology International Standardized Profile RA Relaying the Connectionless-mode Network Service Part 5: Definition of profile RA51.51, relaying the Connectionless-mode Network Service between CSMA/CD LAN subnetworks (ISO/IEC ISP 10613-5: 1994). The Schedule comprises the text of EN ISP 10613-5: 1996.
- (2) The said standard specification may be cited as Irish Standard/EN ISP 10613-5 : 1996 or as I.S./EN ISP 10613-5 : 1996.
- 3. (1) The Standard Specification (Information Systems Interconnection Relaying the Connectionless-mode Network Service Part 5 : Profile RA51.51 (M-IT-02 R/21)) Declaration, 1993 is hereby revoked.
- (2) Reference in any other standard specification to the Instruments hereby revoked and to Irish Standard/ENV 41801-5: 1993 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISP 10613-5:1996.

The text of the International Standard from ISO/IEC/JTC 1 "Information Technology" of the International Organization for Standardization (ISO) and the International Electrotechnical Commission (IEC) has been taken over as a European Standard by CEN Technical Board.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by July 1996, and conflicting national standards shall be withdrawn at the latest by July 1996.
