2. (1) The Specification set forth in the schedule to this declaration is hereby declared to be the standard specification for Optics and optical instruments - Lasers and laser-related equipment - Fibre optic connectors for non-telecommunication laser applications (ISO 11149:1997). The Schedule comprises the text of EN ISO 11149:1997.

(2) The said standard specification may be cited as Irish Standard EN ISO 11149:1998 or as I.S. EN ISO 11149:1998.
