Forfás in exercise of the power conferred by section 20 (5) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Paints and varnishes - Surface-drying test - Ballotini method (ISO 1517 : 1973)) Declaration, 1995.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Paints and varnishes - Surface-drying test - Ballotini method (ISO 1517 : 1973). The Schedule comprises the text of EN ISO 1517: 1995.

(2) The said standard specification may be cited as Irish Standard/EN ISO 1517:1995 or as I.S./EN ISO 1517:1995.
3. (1) The Standard Specification (Paints and varnishes - Surface-drying test - Ballotini method (ISO 1517 : 1973)) Declaration, 1988 is hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/ISO 1517:1988 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISO 1517:1995.
