1. This instrument may be cited as the Standard Specification (Prevailing torque type all-metal hexagon nuts, style 2, with metric fine pitch thread - Property classes 8, 10 and 12 (ISO 10513:1997)) Declaration, 1998.
2. (1) The Specification set forth in the schedule to this declaration is hereby declared to be the standard specification for Prevailing torque type all-metal hexagon nuts, style 2, with metric fine pitch thread - Property classes 8, 10 and 12 (ISO 10513:1997).
